3. CANCELLATION: A full refund of the damage deposit shall be made if the re	servation is

cancelled fourteen (14) days prior to the rental date. Cancellations made less than fourteen (14) days prior to the event the damage deposit will not be refunded. If the Renter fails to pay the full

rental fee by fourteen (14) days prior to the event start date and does not contact the Organization about late payment, the Organization may cancel the event with refund of the deposit. Rental fees received less than fourteen (14) days prior (if communicated to the Organization) will be subject to a \$25 expedience fee. The Renter shall be liable to owner for any legal fees, court costs, and other expenses associated with collection.

CLEANING AND USE: Renter shall adequately clean all common areas to their pre-existing condition, restore furniture to its original position and setup, remove all personal property, trash, and other items that were not present in the venue when Renter took control of it, and shall vacate the premises no later than the termination date of this lease. Use of costumes or props stored in the building is not permitted without approval from a representative of the Organization. Alcohol and tobacco products are not permitted to be used in the building.
- 6. LIABILITY: Renter will be liable for any physical damages, legal actions, and/or loss of reputation or business opportunities that the Organization may incur as a consequence of the actions of Renter or any of Renter's guests while Renter is in control of the venue, and shall indemnify and hold harmless the Organization against any and all legal actions which may arise from Renter's use of the venue.
- 7. LEGAL: Any disputes arising under this contract shall be adjudicated in the Organization's local jurisdiction.
